**PROJECT:** I-180 Viaduct Safety and Enhancements  
**DESCRIPTION:** New Street/Bridge Lighting and Pedestrian Fence next to Sidewalk over the Union Pacific Rail yard between West Lincolnway and 9<sup>th</sup> Street  
**ROUTE NUMBER:** P-25  
**LEAD AGENCY:** WYDOT  
**FUNDING YEAR** 2009  
**AND SOURCE:** \$1,900,000 Federal "American Recovery and Reinvestment Act of 2009"

**PROJECT:** West Lincolnway (US 30)  
**DESCRIPTION:** Reconstruction of West Lincolnway between I-80/Otto Road and Westland Road. Included BOPU Water Main Extension  
**ROUTE NUMBER:** P-56  
**LEAD AGENCY:** WYDOT  
**FUNDING YEAR** 2009  
**AND SOURCE:** \$14,300,000 Federal "American Recovery and Reinvestment Act of 2009"

**PROJECT:** West Lincolnway (US 30)  
**DESCRIPTION:** Construction of landscaped and Lighted Medians on the West Lincolnway Project between I-80/Otto Road and Westland Road.

**LEAD AGENCY:** City/WYDOT  
**FUNDING YEAR** 2009  
**AND SOURCE:** \$1,800,000 Federal "American Recovery and Reinvestment Act of 2009"

**PROJECT:** Carey Avenue and Pioneer Avenue  
**DESCRIPTION:** Reconstruction and/or Overlays of both Carey and Pioneer between West Lincolnway to 24<sup>th</sup> Street. Includes BOPU Water and Sewer Main Replacement.  
**ROUTE NUMBER:** U-4023 and U-4024  
**LEAD AGENCY:** City and BOPU  
**FUNDING YEAR AND SOURCE:** 2009

**DESCRIPTION:** Three New Energy Efficient, Hybrid or CNG Buses for the Cheyenne Transit Program  
**LEAD AGENCY:** Cheyenne Transit Program  
**FUNDING YEAR AND SOURCE:** 2009  
\$242,800 Federal "American Recovery and Reinvestment Act of 2009"

**PROJECT:** Transit Bus  
**DESCRIPTION:** New Bus for the Magic City Enterprise  
**LEAD AGENCY:** Magic City Enterprise  
**FUNDING YEAR AND SOURCE:** 2009  
\$52,500 Federal "American Recovery and Reinvestment Act of 2009"

**PROJECT:** Cheyenne Transit Bus Pullouts/Shelters  
**DESCRIPTION:** 50 New Bus Pull Outs and Shelters around the Cheyenne Urban Area  
**LEAD AGENCY:** Cheyenne Transit Program  
**FUNDING YEAR AND SOURCE:** 2009  
\$900,000 Federal "American Recovery and Reinvestment Act of 2009"

**PROJECT:** Clear Creek Parkway  
**DESCRIPTION:** Construction of 5,550 linear feet, the last phase of Clear Creek parkway to connect the previous IRP roadways projects to the new High Plains Road Interchange (AKA Speer). The improvements will consist of a three lane rural collector and complete a 3.14 mile roadway project between College Drive and the High Plains Road I-25 Interchange.  
**ROUTE NUMBER:** U-4100  
**LEAD AGENCY:** County  
**FUNDING YEAR AND SOURCE:** 2009 \$1,700,000 Federal “American Recovery and Reinvestment Act of 2009”

**PROJECT:** Division Avenue  
**DESCRIPTION:** Construction of 5,400 linear feet of Division Avenue between College Drive and Wallick Road. The improvements will consist of a three lane Urban Collector including curb and gutter, detached 5’ sidewalks, public utilities and will provide neighborhood connectivity.  
**ROUTE NUMBER:** U-4018  
**LEAD AGENCY:** County  
**FUNDING YEAR AND SOURCE:** 2009 \$3,200,000 Federal “American Recovery and Reinvestment Act of 2009”

**PROJECT:** Wallick Road  
**DESCRIPTION:** Construction of 2,600 linear feet of Wallick Road between Division Avenue and South Greeley Highway. The improvements will consist of a three lane Urban Collector including curb and gutter, detached 5’ sidewalks, public utilities and will provide neighborhood connectivity.  
**ROUTE NUMBER:** U-4018  
**LEAD AGENCY:** County  
**FUNDING YEAR AND SOURCE:** 2009 \$1,500,000 Federal “American Recovery and Reinvestment Act of 2009”

**PROJECT:** Avenue C  
**DESCRIPTION:** Reconstruction of 5,280 linear feet of Avenue C between Fox Farm Road and College Drive. The improvements will consist of a three lane Urban Collector including curb and gutter, detached 5’ sidewalks, public utilities, drainage improvement at Allison Draw, and will provide neighborhood connectivity.

**FUNDING YEAR AND SOURCE:** 2009 \$3,000,000 Federal “American Recovery and Reinvestment Act of 2009”
