4. **AMENDED AND RESTATED MASTER AGREEMENT BETWEEN THE WYOMING DEPARTMENT OF TRANSPORTATION, AND THE CHEYENNE METROPOLITAN PLANNING ORGANIZATION** – The MPO and WYDOT spent time working through this document to update from the last version adopted in 2014. Currently the AG is reviewing the document.
5. **Vote for Approval: (DRAFT) UPWP FY '26** – Review (DRAFT) UPWP FY '26 and help select which proposed projects the MPO should include in the UPWP.
 - a) Parsley Blvd and Wallick Dr Extensions, estimated \$450,000
 - b) Greenway Connections – Henderson Drive to Cahill Park, estimated \$207,500
 - c) Ames Ave Corridor with Pump House Access Study, Estimated \$180,000
 - d) West 15th St Corridor, estimated \$175,000
 - e) Lincolnway Corridor, Estimated \$180,000
 - f) Missile Drive Right Sizing Corridor, Estimated \$350,000
 - g) Southwest Cheyenne Connector Bypass – I-25 to I-80 Corridor, Estimated \$500,000
6. **Safe Routes to School** – by Stantec. A Contract Modification \$39,510.27 with City match \$19,755.13 and County match \$19,755.14 being processed to expand by adding the following schools.

7. **West Crow Creek Greenway –** Ayres. Continuing to move forward on the project and is scheduled to be finished in FY '26 Q1.
8. **CONNECT 2050 –** Kimley Horn. On track and moving forward with all data received from the MPO. Kimley Horn has been working on updates and survey information collected from OCAC and MPO website (Map and survey). A Pop-Up event occurred at the Pedestrian & Cyclist Safety Workshop hosted by Wyoming Pathways on August 8, 2025.
9. **Safe Streets for All Comprehensive Action Plan –** FHU. RFP plan was advertised January 4, 8, 2025 and the MPO received five proposals from Ayres, FHU, HDR, Kimley Horn, and Stantec. The selection committee reviewed, and the consensus was that FHU to be selected for the plan. The contract was finalized and submitted to City Council and approved on June 4, 2025, with a grant of \$200,000.00 and a City match of \$32,500.00 and County match of \$17,500.00. An MOU for the County to reimburse the City on this plan was sent over to the County and approved. This plan will take 12-14 months to complete. A Pop-Up event occurred at the Pedestrian & Cyclist Safety Workshop hosted by Wyoming Pathways on August 8, 2025. Another Pop-Up is scheduled for August 14, 2025, at Fridays on the Plaza (4pm – 6pm). The link for the survey and map is now live for public comment.
