- 6. Safe Streets for All Comprehensive Action Plan FHU. RFP plan was advertised January 4, 8, 2025 and the MPO received five proposals from Ayres, FHU, HDR, Kimley Horn, and Stantec. The selection committee reviewed, and the consensus was that FHU to be selected for the plan. The contract was finalized and submitted to City Council and approved on June 4, 2025, with a grant of \$200,000.00 and a City match of \$32,500.00 and County match of \$17,500.00. An MOU for the County to reimburse the City on this plan was sent over to the County and approved. This plan will take 12-14 months to complete. A Pop-Up event occurred at the Pedestrian & Cyclist Safety Workshop hosted by Wyoming Pathways on August 8, 2025. Another Pop-Up was held August 14, 2025, at Black Tooth Brewery (4pm 6pm).
- 7. **East Allison Road Corridor Study** Stantec. RFQ plan was advertised September 20 & 27, 2025 and the MPO received seven proposals from BenchMark Engineers, DJ&A, Y2 Consultants, JR Engineering, Kimley Horn, Stantec and Ulteig. The East Allison Road Corridor Study will evaluate roadway, drainage, utility, and multimodal needs along East Allison Road in South Cheyenne. The study area extends from South Greeley Highway (US 85) to the existing west end of East Allison Road near the Laramie County School District No. 2 campus, a total of approximately 0.9 miles. The study is divided into two phases, with Phase 1 advanced to ~30% design for greater accuracy at the US-85 gateway and extended to Avenue C, and Phase 2 delivered at ~10% conceptual level with centerline survey from Avenue C to the east end of the existing East Allison Rd in Niobrara Industrial Park. The study will also include a review of a potential roundabout at the East Allison Road & Avenue C intersection. Currently, we are working on negotiating project costs with Stantec.
